

Indecent behaviour lands 34 in court

Kuala Lumpur, Mon: Thirty-four transvestites were charged in a magistrate's court here today with indecent behaviour in a public place while eight of them also faced an additional charge of not having identity cards.

Thirty-two men aged between 18 and 41 pleaded guilty to the first charge of indecent behaviour by wearing women's clothes at Jalan Sultan Ismail and Jalan Haji Taib at 1am on March 24 whereas the eight admitted to the second offence committed at the same place and time.

Magistrate Madihah Harullah fined them RM 25 each for the first offence and RM 50 each for the second. All paid the fines.

In mitigation, defence counsel for the two who claimed trial, **Jerald Gomez**, requested the court to fix bail at RM 25, which is equivalent to the maximum fine imposed.

Madihah, however, ordered bail to be set at RM 500 each.



YAMAHA 分行经理 被控偷 14 万元乐器

(吉隆坡 10 日讯) 雅马哈乐器分销店分行的一名华裔经理今日被控偷走店内总值超过 14 万令吉的多种乐器，被告不认罪，获准以 1 万 5 千令吉保外候审，推事庭定于明年 1 月 11 日过堂。

36 岁的被告李忠志 (译音) 是八打灵再也雅马哈乐器分销分店的经理，雇主阿美娜指控他偷窃，并于 10 月 31 日遭警方逮捕。

可被判入狱 7 年

控状指他于今年 4 月 1 日至 9 月 26 日期间，在隆市武吉免登路吉隆坡广场的分店内，身为雅马哈音乐私人有限公司的员工却盗走多件乐器，总值 14 万 2 千 755 令吉 51 仙，触犯刑事法典第 381 条文，一旦罪成，可被判入狱达 7 年，并可另加罚款。

被告不认罪，主控官陈文信向推事建议让被告以 2 万令吉保外候审，被告的未婚妻为担保人。

被告的代表律师杰生向推事要求减低保释金，原因是被告从逮捕日至今日出庭面控都获得警方担保。

KUALA LUMPUR: A former store manager claimed trial at the magistrate's court here yesterday to criminal breach of trust involving \$109,979.18. Koh Thin Lai, 37, of Jalan Mesin here, is charged with misappropriating the amount entrusted in his care as the store manager of Bata (M) Sdn Bhd at its premise in 122-124 Jalan Tuanku Abdul Rahman between June 30 and July 20 last year.

Mr Jerald Gomez successfully defended **Mr Koh Thin Lai** against the CBT charge
